





# Kingdom of Saudi Arabia

- 2<sup>nd</sup> largest oil reserves in the world
- 830,000 sq. miles in area
  - 5 times bigger than California
- Population 34 million
- GDP \$1.8 Trillion (PPP\*)
  - \$780B nominal
  - Per capita \$56.8K (PPP), \$26.5K nominal

\*GDP PPP (purchasing power parity) is gross domestic product converted to international dollars using purchasing power parity rates. An international dollar has the same purchasing power over GDP as a U.S. dollar has in the United States











#### Fertile Crescent: Cradle of Civilization




#### Fertile Crescent: Cradle of Civilization


- Birthplace of human civilization
- Called "the fertile crescent" because of its lush soil, the "crescent" of land mostly includes modern-day Iraq, Syria, Jordan, and Israel-Palestine
- People started farming here in 9000 BC, and by around 2500 BC the Sumerians formed the first complex society that resembles what we'd now call a "country," complete with written laws and a political system

# Life of Mohammad: Prophet of Islam

- Marries at 25, with a 40-year old rich widow who had a trading business
- He becomes a trader carrying merchandize to the Red Sea
- Becomes discontent, spends time alone meditating in a cave
- Receives first revelation of Islam at age 40 (610AD)



# Life of Mohammad: Prophet of Islam

- Starts preaching locally by 613 AD- meets a lot of resistance
- Followers grows but challenging establishment threatens life
- Migrates to Medina in 622 AD with his followers & establishes government
- Mohammad dead in 632 AD (age 63)

## **Five Pillars of Islam**


- 1. Confession of faith in God & Muhammad as his messenger
- 2. Fasting during the month of Ramadan
- 3. Daily prayers 5-times a day (hygiene & flex)
- 4. Pay alms/charity 2.5% of wealth to the poor every year
- 5. Once in life pilgrimage to Mecca (if possible)

#### **Similarities & Differences**

- Islam recognizes & tells stories that are similar to what is in the bible
  - Adam, Noah, Abraham, Joseph, Jesus, Moses, resurrection, virgin birth, heaven, hell etc.
- Differs in the concept of trinity
- Establishes Muhammad as the final & last prophet


## Why Islam Spread so Fast?

- Islam provided rules & governing structure
- Government must protect all non-Muslims if they pay a tax (or convert to Islam)
- Islam introduced:
  - Women's rights (ownership of property, divorce...)
  - Inheritance rights
  - Protection for minorities




#### **How Islam Differs**

- Main focus is on Ummah (Community)
  - Peace & justice are main focus for the religion
- Set of rules on governance, inheritance & conduct in society
- No concept of "separation of church & state" – Church IS THE STATE

#### **Role of Religion in Arabian Peninsula**

 Suddenly Hejaz (Mecca & Medina as main cities) becomes the center point in an expanding Muslin world

 Schism within Islam started & has created deep tensions over the years that can result in war with deep impact on the world

#### Shia-Sunni Split

- Who is the rightful successor after Mohammad's death?
  - Next of kin? [that would be Ali, his son-in-law & protégé]

Or

Senior most & capable person as chosen by a body of elders

# The Big Split: Shia & Sunni Islam

- Started on succession question after the death of Mohammad in 632 AD
- Should Ali (his son-in-law & protégé) succeed or should it be based on seniority & caliber?
- Animosity led to bloodshed, wars & different rituals of practicing Islam




# Most Famous Shia Leader: Prince Karim Aga Khan IV

- Leader of the Ismaili sect of Shia
  - The 49<sup>th</sup> Imam
- One of the richest man in the world
- There are many sects with Shia as well as Sunni factions



#### Shia: 5% to 10% of 1.5B Muslims

Many factions within Sunni & Shia split – Iran (population 20 million) is largest Shia state (Iraq, Bahrain, Azerbaijan, India also have significant % as Shia)



## Umayyad Dynasty

- At its greatest extent, the Umayyad Caliphate (661–750) covered 4,300,000 sq. miles & 62 million people (29% of world's population)
  - making it one of the largest empires in history in both area and proportion of the world's population
- It was also larger than any previous empire in history.




# Nomadic Land of Little Consequence – 10<sup>th</sup> Century Onwards

- From the 10th century to the early 20th century, Mecca and Medina were under the control of a local Arab ruler known as the Sharif of Mecca
- Sharif owed allegiance to the ruler of one of the major Islamic empires based in Baghdad, Cairo or Istanbul
- Most of the remainder of what became Saudi Arabia reverted to traditional tribal rule

### **Ottoman Rule Over Arabian Peninsula**


- In the 1517, the Ottomans (Selim) added the Red Sea & Persian Gulf coast & claimed suzerainty over interior
  - Thwart Portuguese attempts to attack Red Sea & Indian Ocean



### Wahhabi-Saudi Deal of 1744

- In 1744, Muhammad ibn Abdel Wahhab formed an alliance with Muhammad ibn Saud, the ruler of the nearby town of Diriyah
- Ibn Saud then set out to conquer the surrounding region with the goal of bringing it under the rule of a single Islamic state

### **Evolution in Arabian Peninsula**


- The House of Saud is the ruling royal family of Saudi Arabia
- It is composed of the descendants of Muhammad bin Saud, founder of the Emirate of Diriyah, known as the First Saudi state (1744–1818)
  - and his brothers, though the ruling faction of the family is primarily led by the descendants of Ibn Saud, the modern founder of Saudi Arabia

## **Thomas Edward Lawrence**

- T. E. Lawrence (1888 1935)
- British archaeologist, army officer, diplomat, & writer



- Renowned for his role in Arab Revolt & Sinai & Palestine Campaign against the Ottoman Empire during the First World War
- The breadth + variety of his activities & associations, & his ability to describe them vividly in writing, earned him international fame as Lawrence of Arabia
  - a title used for 1962 film based on his wartime activities

# Arab Revolt

 Initiated by Hussein bin Ali, Sharif of Mecca, at Mecca on 10 June 1916 with the aim of securing independence from the ruling Ottoman Turks & creating a single unified Arab state stretching from Aleppo in Syria to Aden in Yemen



The Sykes–Picot Agreement officially the Asia Minor Agreement, was a secret 1916 agreement between United Kingdom & France, to which the Russian Empire assented

It negated UK's promises to Arabs made for a national Arab homeland in the area of Greater Syria, in exchange for supporting the British against the Ottoman Empire

# Sykes–Picot Agreement 1916

- The agreement allocated to Britain control of areas roughly comprising the coastal strip between the Mediterranean Sea and the River Jordan, Jordan, southern Iraq, and ports of Haifa and Acre
- France got control of southeastern Turkey, northern Iraq, Syria and Lebanon
- Russia was to get Istanbul, Turkish Straits + Armenia








## The History of The House of Saud

- 1<sup>st</sup> Saudi state (1744-1818)
  - Post alliance, marked by the expansion of Wahhabism; the Emirate of Nejd
- 2<sup>nd</sup> Saudi state (1826-1891)
   marked with continuous infighting
- 3<sup>rd</sup> Saudi state (1902-present)
  - Because Saudi Arabia in 1932
  - Now wields considerable influence in Middle East

# The House of Saud Unified by Abdul Aziz in 1902

- The family has had conflicts with the Ottoman Empire, the Sharif of Mecca, the Al Rashid family of Ha'il and their vassal houses in Najd, numerous Islamist groups both inside and outside Saudi Arabia and Shia minority in Saudi Arabia
- The succession to the Saudi Arabian throne was designed to pass from one son of the first king, Ibn Saud, to another





### **Unification Under Ibn Saud 1932**

 Hejaz got independence from British after WW1 but were conquered by Ibn Saud by 1925



### Abdul-Aziz ibn Abdul Rahman ibn Faisal ibn Turki ibn Abdullah ibn Muhammad Al Saud 1875-1953

Founder of modern Saudi Arabia in 1932

Fathered 45 children & all future kings of KSA

# **Search for Oil Begins**

- WW1 petrol shortage accelerated search
- Ibn Saud seeks help from
  - Major Frank Holms (New Zealander) in 1922
  - Went to US & created Gulf Oil in 1927
  - But was forced to sell its interests
    - Red Line Agreement got in the way!



# IPC (Iraqi Petroleum Company) Redline Agreement: First Cartel 1928

- The agreement was signed between Anglo-Persian Company (British Petroleum), Royal Dutch/Shell, Compagnie Française des Pétroles (later renamed Total), Near East Development Corporation (later renamed ExxonMobil)
- To formalize corporate structure of IPC & bind all partners to a "self-denial clause" that prohibited any of its shareholders from independently seeking oil interests in the ex-Ottoman territory

#### SOCAL bought the right from Gulf Standard Oil Company of California → Chevron



# **Oil Discovered**


- American mining engineer Karl Twitchell saw the potential & helped in bidding in 1933
- Under the agreement, SOCAL was given "exploration rights to some 930,000 square kilometers of land for 60 years
- Oil discovered in 1938 in Eastern Saudi Arabia

# 92% of Saudi Revenue from Oil

SOCAL set up a subsidiary company, the California Arabian Standard Oil Company (CASOC) to develop the oil concession. SOCAL also joined forces with the Texas Oil Company when together they formed CALTEX in 1936




### Saudi ARAMCO

- 1933: California-Arabian Standard Oil Company
- 1943 Name changed to Arabian-American Oil Company
- 1988 Bought out as Saudi Arabian Oil Company: Saudi Aramco
- Total reserves: 270 billion barrels of oil
  - 288.4 trillion cubic feet of natural gas
- Production: 3.4 B barrel per year (~9 mbpd)

#### Historical Crude Oil prices, 1861 to Present



 During the 1973 oil crisis, the price of oil rose from \$3 per barrel to nearly \$12, and the Saudi economy began to grow rapidly with GDP increasing from approximately \$15 billion in 1973, to approximately \$184 billion by 1981





### The House of Saud

- Succession to Saudi Arabian throne was designed to pass from one son of the first king, Ibn Saud, to another
- King-appointed cabinet includes members of royal family
- The monarchy was hereditary by agnatic seniority until 2006, when a royal decree provided that future Saudi kings are to be elected by a committee of Saudi princes

## Kingdom of Saudi Arabia

- King Salman, who reigns currently, chose first his nephew and then his son as the crown prince after he was approved by the Allegiance Council with 31 out of 34 votes
- The family is estimated to comprise 15,000 members, but the majority of the power and wealth is possessed by a group of about 2,000 of them

# Mohammad bin Salman bin Abdulaziz Al Saud (MbS)

- Crown Prince of Saudi Arabia
- Currently serving as the deputy prime minister (the title of prime minister being held by the king)
- Chairman of the Council for Economic and Development Affairs
- Chairman of the Council of Political and Security Affairs
- Minister of Defense



### The Prince Visits Google

- 34-year old heir apparent MBS
- Prince Mohammed has spent his fortune on a \$500 million yacht, a \$300 million French chateau, and a \$450 million Leonardo da Vinci painting
- Cost of Saudi Royal family
  - ~15,000 princes & princesses
  - Total cost \$10B annual allowance




## The Saudi Economy

- The petroleum sector accounts for roughly 87% of Saudi budget revenues, 90% of export earnings, and 42% of GDP of \$786 Billion
- Huge push on diversifying the economy
   Petroleum products, plastics, chemicals

# Saudi Workforce

- 90% of the private sector workforce is imported in 2008
- Only 30% to 40% of Saudis seek jobs
- Jobs in service and sales are considered totally unacceptable for citizens of Saudi Arabia—both potential employees & customers

- Law forces any foreign entity to have Saudi partner to conduct business
- Passive income is the way to live in KSA

## **US Saudi Relations: Mutual Benefits**

 Offer military protection for Saudi Arabia's oil fields, in return Saudi's would price their oil sales exclusively in USD (Saudis were to refuse all other currencies, except U.S. dollar, as payment for their oil exports)

## **US Saudi Relations: Mutual Benefits**

- US wanted stable oil production & support in Persian Gulf & signed most favored nation 1931
- Dip in relationship happened in 1973 with oil embargo, lifted in 1974 with KSA buying \$2B of arms
- \$120B of arms sale to KSA during Obama admin.

# **Conflicts Emerged but "Managed"**

- Oil embargo of 1973
- 911 attacks
- Support of terrorist factions (Sunni vs. Shia)
- 2017 US arms-deal & war in Yemen

- \$110B weapon purchase now, \$350B over 10-years

## **Latest Crisis**

- Saudi dissident, journalist for Washington Post, & former GM & editor-in-chief of Al-Arab News Channel
- Killing occurred on 2 October 2018 at Saudi consulate in Istanbul, Turkey, & was perpetrated by agents of KSA
- Lured to the consulate building on the pretext of providing him papers for his upcoming wedding, Khashoggi was ambushed, suffocated, & dismembered

- Conservative movements sprung up around the world as a result of excessive & radical 1960s & 1970s










## **1979: Siege of Mecca by Hardliners**


 Saudi hardliners revolted against the Al Saud & took over Mecca
 Compound by force



Juhayman al-Otaybi



Siege ended after 2 weeks, 67 were captured & later beheaded → resulted in stricter sharia laws to appease the hardliners



## This event turned the tide to much stricter laws & establishment of religious (moral) police in Saudi Arabia

# **Events Shaping History in 1979**

- 1. Iranian revolution
- 2. Siege of Mecca
- 3. Soviet invasion of Afghanistan

The hardliners gained momentum & shaped the political future of the Islamic world – that was further amplified by actions by the West in Iraq, Palestine & elsewhere

## The Neighborhood

## Yemen

- 25% larger than Calif in area
- Population: 28 million
- 2013 GDP (PPP) of US\$61.63 billion, with an income per capita of \$2,500
- Services are largest economic sector (61.4% of GDP) industrial sector (30.9%), agriculture (7.7%)
- Petroleum production represents ~ 25% of GDP & 63% of revenue



## Yemen's Civil War: 2015

- Saleh ruled Yemen for decades, (Hadi was his VP) but aligned with the Houthi (Shia) led revolutionaries
- Hadi assumed power in 2012 & requested Saudi intervention




## Yemen-Saudi War

 President of Yemen Hadi ousted by the Houthi (Shia) movement due to economic & political grievances

- he fled to Saudi Arabia & asked for Saudi help

 Intervention launched by Saudi Arabia in 2015, leading a coalition of nine countries from West Asia and Africa Yemen's Civil War Started in 2015 as Shia (Iranfunded) faction took over Sana'a



Controlled by Houthis and Saleh loyalists
 Controlled by Saudi-backed Hadi loyalists
 Controlled by al-Qaeda and Islamic State of Iraq and the Levant-affiliated Ansar al-Sharia
 Controlled by the UAE-backed Southern Transitional Council




## Sultanate of Oman

- Was a regional power in 1700s aligned with Portugal & Britain
- Lead by Sultan Qaboos bin Said since 1970s
- Strategic counter weight to Iran across the Strait of Hormuz
- Muscat (Capital) is key trading post in the Persian Gulf
- Population ~5 million
- 20% smaller than CA in area
- GDP of \$76B (\$204B in PPP)








## War Scenario

- Many attitudes & traditions are centuries-old, from Arab civilization & Islamic heritage





# Dos & Don'ts in Saudi Arabia








